## Software License Agreement

**Before using the software contained in this package, you should carefully read the terms and conditions of this license agreement. If you find any of the terms of this license agreement objectionable, please contact Larson Software Technology (LST) or your Supplier.**

Subject to the provisions contained herein, LST hereby grants to you a non-exclusive license to use its proprietary computer software products ("Software") contained in this package. As described below, your use of the Software, when enabled, is limited to a Designated CPU or Licensed "Number" of simultaneous users.

**PASSWORD/ACTIVATION** LST or Supplier shall provide you with a temporary password at time of installation, corresponding to the Designated CPU or number ("Number") depending on whether the license type is Desktop, Server or Network as listed on your purchase order or invoice from LST or Supplier. Once final payment has been received by LST via the User or Supplier, a permanent password will be supplied to the User for the ("Number") and type of licenses listed on your purchase order or invoice from LST or Supplier.

**LICENSE TERM AND CHARGES** The term of this license(s) commences upon delivery of the Software to you and is perpetual unless earlier terminated upon default by one of the parties or as otherwise set forth herein. The license fee corresponds to the Number of concurrent users. If the desired Number increases, then after payment to LST or Supplier the applicable price, LST will provide you with a password(s), which will enable the new Number. **Notwithstanding the foregoing, if the Software or Documentation is being provided for demonstration or evaluation purposes only, then your license to use the Software shall automatically terminate fifteen (15) days (or such longer period as authorized by LST or Supplier) after you commence using the Software, all Software and Documentation and all copies thereof, must be destroyed.**

**TITLE** Title, and ownership rights, and the intellectual property rights in and to the Software and Documentation, shall remain in LST. The Software is provided for your internal use under this license. This license does not include the right to sublicense and is personal to you and therefore may not be assigned (by operation of law or otherwise) or transferred without prior written consent of LST. You acknowledge that the Software in source code form remains a confidential trade secret of LST and therefore you agree not to attempt to decipher or decompile the Software or develop source code for the Software or knowingly allow others to do so. You also agree not to develop passwords or to alter the Number, or to determine how LST develops such password(s) or to otherwise enable the Number for concurrent users not licensed or to knowingly allow others to do so.

**UPDATES** This license does not grant you any right, license or interest in and to any improvements, modifications, enhancements or updates to the Software or Documentation. Updates, if available, may be obtained by you at LST's then current standard pricing, terms and conditions. If the media inside the package is an update, then the Documentation provided may be limited in scope and a new password(s) may or may not be required or supplied by LST.

**LIMITED WARRANTY** LST warrants that for a period of thirty (30) days from the date of license purchase, the Software, if operated as directed, will substantially achieve the functionality described in the Documentation. LST does not warrant, however, that your use of the Software will be uninterrupted or that the operation of the Software will be error-free. LST also warrants that the media containing the Software, if provided by LST, is free from defects in material and workmanship and will so remain for thirty (30) days from the date you purchased a license to it. LST's sole and exclusive obligation and liability for any breach of the warranty shall be, in LST's sole discretion: (i) to replace or correct your defective media so that it will conform to the above warranty shall be; (ii) to advise you how to achieve substantially the same functionality with the Software as described in the Documentation through a procedure different from that set forth in the Documentation. Only if you inform LST or Supplier of your problem with the Software during the applicable warranty period will LST be obligated to honor this warranty. You must contact LST or Supplier by telephone, email, fax or letter to inform LST of the problem. **THIS IS A LIMITED WARRANTY AND IT IS THE ONLY WARRANTY MADE BY LST. **SUPPORT AND TRAINING** Technical Support after the 30 day warranty period and training for the Software shall be provided by LST or Supplier at the current standard pricing, terms and conditions. Annual Support is available for an additional charge.

**LIMITATION OF LIABILITY** Your Sole and exclusive remedies for any damage or loss in any way connected with the Software, whether by LST's breach of any express or implied warrant, negligence or breach of any other duty, shall be, at LST's option, repair or replacement of the Software. Under no circumstances and under no legal theory, tort, contract or otherwise, shall LST be liable to you or any other person for any indirect, special, incidental or consequential damages of any character including, without limitation, damages for loss of goodwill, work stoppage, computer failure or malfunction, or any and all other commercial damages or losses, or for any damages in excess of LST's list price for a license to the Software and Documentation, even if LST shall have been informed of the possibility of such damages, or for any claim by any other party. Your obligations to pay accrued charges and fees shall survive any termination of this Agreement.

**MISCELLANEOUS** This Agreement represents the complete and exclusive statement of the agreements concerning this license between the parties and supercedes all prior agreements and representations between them.
